JSMEA Holds Turkey Japan Maritime Business Matching Forum 2023

Japan Ship Machinery and Equipment Association (JSMEA) held a Turkey Japan Maritime Business Matching Forum 2023 in Istanbul on Nov. 8 with financial support from The Nippon Foundation. Partly at the request of the Turkish Shipowners' Association (TSA), the event, which welcomed some 180 individuals from the local maritime industry, facilitated direct business negotiations between participants, while showcasing Japanese ship machinery and equipment, particularly on eco-friendly, energy-saving and new fuelcompatible products. The 14 attending JSMEA member companies introduced their products and technologies in detail at negotiating tables. There was also a question-and-answer session as well as active SMEA was represented by Chairman Kinoshita Shigeki; Vice-Chairmen Kinoshita Kazuhiko, Kuzu Tomoo and Oda Masato; Overseas Market Development Working Group Leader Urabe Reijiro; and Overseas Fishing Vessel Market Development Working Group Leader Ueda Shuzo; leading a delegation of 55 members from the 14 affiliated companies.



During the Turkey Japan Maritime Business Matching Forum 2023, presentations were given to promote Japanese ship machinery and equipment products. Chairman Kinoshita spoke on the efforts of Japanese ship machinery and equipment manufacturers to reduce greenhouse gas (GHG) emissions with the Green Innovation Fund, which was established by Japan's

Ministry of Land, Infrastructure, Transport and Tourism (MLIT) at the New Energy and Industrial Technology Development Organization (NEDO) to meet Japan's goal towards achieving carbon neutrality by 2050. TSA Chairman Cihan Ergenc, in return, delivered a message to Japanese manufacturers and briefed Turkish shipowners and the challenges they face. Along with Chairman Ergenc, Vice-Chairman Murat Er and other board members were also present at the forum on behalf of the TSA.

With the success of the Turkey Japan Maritime Business Matching Forum 2023, Overseas Fishing Vessel Market Development Working Group Leader Ueda took delegation members to Trabzon in northeast Turkey on Nov. 10. They visited local fishing vessel builders Basaran Gemi Shipyard and Sengun Gemi Shipyard to observe shipbuilding work on site, exchanging opinions on fishing vessel market developments among other subjects. They also attended a lecture on shipyards in Trabzon from a local fishing vessel organization, Sinirli Sorumlu Sac Gemi Ahsap Tekne Ve Kotra Imalatcilari Kucuk Sanat Kooperatifi.


JSMEA Participates in Marintec China 2023


The Japan Ship Machinery and Equipment Association (JSMEA) took part in Marintec China 2023 on Dec. 5-8, 2023 at the Shanghai New International Expo Center (SNIEC).


Held every other year, Marintec China is one of the most authoritative international exhibitions for the maritime industry. It was held for the first time in four years—since 2019—after being cancelled in 2021 due to the coronavirus pandemic. A total of 14 countries and regions hosted national pavilions, where more than 2,200 enterprises held exhibitions, according to the event's organizer. The national pavilions welcomed a total of over 80,000 visitors, greater than the number of visitors at Marintec China 2019, which attracted some 60,000 visitors. JSMEA set up a Japan Pavilion together with Nippon Kaiji Kyokai (ClassNK) and 30 JSMEA member companies.











On Dec. 4, the day before the opening of Marintec China 2023, Mitsui O.S.K. Lines (MOL), one of the JSMEA delegation members giving exhibitions at the Japan Pavilion, delivered a presentation at the Senior Maritime Forum, which was held at the Kerry Hotel Pudong, located next to the Marintec China 2023 venue. In the presentation entitled "Wind Hunter Project/Creating our Future with Wind and Hydrogen (Zero Emission Project)," MOL introduced its Wind Hunter Project and other efforts that the company is making to achieve zero emissions.

On Day 2 at Marintec China 2023, JSMEA met with the China Association of the National Shipbuilding Industry (CANSI), at which JSMEA Chairman Kinoshita Kazuhiko and Vice-Chairman Kuzu Tomoo held round-table talks with CANSI Chairman Guo Dacheng and Deputy Secretary-General Chen Wenbo. After sharing with each other how Japan and China are working respectively to accommodate new fuels, the organizations exchanged views on other relevant matters. They discussed, among other things, the progress of their respective nations' autonomous ship development. Referring to China-Japan joint ventures that have been set up and succeeded in business in China, and other examples, CANSI Chairman Guo indicated that the Chinese shipbuilding and ship machinery and equipment industries want to cooperate with their Japanese counterparts in adopting new fuels and developing autonomous ships. JSMEA and CANSI agreed to continue their efforts to maintain and even enhance their cooperation and partnerships.

JSMEA Exchanges Information with Brazilian Offshore-, Maritime-Concerned Parties

A delegation from the Japan Ship Machinery and Equipment Association (JSMEA) met with groups and individuals attached to Brazilian offshore development and maritime industries on Aug. 24, 2023.

The coronavirus pandemic had limited their information exchanges to online. During that time, however, many JSMEA-affiliated companies wanted more information on Brazil, as offshore oil and gas development is becoming increasingly active off the coast of Guyana, located north of Brazil, and oil prices are surging on a global scale.

At the August 2023 meeting, several Brazilian companies mentioned specific projects and challenges they face in advancing the projects. The Japanese ship machinery and equipment industry is eager to get involved in such projects.

JSMEA Holds Ship Machinery, Equipment Seminar in Taiwan

The Japan Ship Machinery and Equipment Association (JSMEA) held a seminar on ship machinery and equipment for fishing vessels in Kaohsiung, Taiwan on Feb. 21, 2024 with financial assistance from The Nippon Foundation. The JSMEA event received organizational support from five local organizations: the Taiwan Deepsea Tuna Longline Boatowners and Exporters Association (TDTLBEA), the Taiwan Squid and Saury Fisheries Association (TSSFA), the Taiwan Tuna Purse Seiners Association (TTPSA), the Kaohsiung Fishermen's Association (KFA) and the Taiwan Shipbuilding Industry Association (TSIA).

Interest was high for the products brought from Japan.

On behalf of JSMEA, Mr. Ueda Shuzo, who presides over the Overseas Fishing Vessel Market Development Working Group at the association, led a delegation of members from 17 affiliated companies. From Taiwan, 208 individuals attended the seminar as representatives of fishing vessel owners, fishery companies, shipbuilders and others from relevant industries.

At the ship machinery and equipment seminar, no presentations were given to promote products. Instead, the delegation members opened booths for business negotiations and other interactions with local attendees. Products brought from Japan were showcased at the booths, where more information was also available in catalogs, tablet computers and other means.

At the beginning of the seminar, Mr. Ueda extended his thanks to Taiwan for providing support after devastating earthquakes hit the Noto Peninsula in central Japan on New Year's Day. JSMEA has developed good relations with the Taiwanese fishery sector for a long time now, he said, adding that the association wants to not only maintain those strong ties but further enhance them as well.

The five local organizations repaid Mr. Ueda's compliments, saying that Japanese ship machinery and equipment as well as fishing implements are important supplies for Taiwanese fishing vessels and inseparable to the Taiwanese fishery business. As fishing vessel bunker costs have been sharply rising in recent years, they hope that energy-saving products from Japan will make huge contributions to the Taiwanese fishery and shipbuilding industries. A feedback from one of the attendees indicated that although they already have regular contact with local agents, it was nice to directly exchange views with Japanese manufacturers and hear lectures on their new technologies.

Members of the JSMEA delegation also highly rated the seminar, with some replying that it was meaningful to hold business talks with many local ship owners. Others were pleased with the chance to meet with many whom they normally do not have direct contact as the number of occasions to meet with fishing vessel owners have decreased since the coronavirus pandemic. Others said that the event had provided chances to interact with more ship owners than expected, which they hope will lead to future business opportunities. Based on these and other similar comments, the ship machinery and equipment seminar was regarded a success as the JSMEA delegation was able to have interchanges with parties from the local fishery and shipbuilding industries and promote their products, services and so on.
